# VILLAGE OF WASKATENAU Regular Council Meeting April 22, 2014

Call to Order

Richard Jean of Joly, McCarthy & Dion presented the 2013 audited Financial Statements.

#### Foreman's Report

Don Rosa reported to Council. (written report attached).

- Incoming chlorine at 1.63 mg/l.
- Chlorimeter was serviced by ClearTech and they will send us a certification certificate.
- An adjustment to the tower fill switch was done.

Telus advised the module will be obsolete by 2015 and must be changed. Mayor Caron will obtain a cost estimate for the work from Pyramid Corporation and Council requested Administration to obtain a cost for the installation of new land line service as another option.
