Clayton Didier - The Group

- Council advised that Smoky Lake County provided consent to the Village to purchase the C.N. Lands.
- Clayton Didier advised he reached out and had a discussion with Chris Down from Travel Alberta regarding our Expression of Interest.
- Expression of Interest submitted to Travel Alberta for grant funding was declined and the Expression of Interest sent to PrairiesCan has not moved to the application stage.
- The Village will have more time to potentially reduce the project cost and overall project description.
- A Business Plan needs to be prepared for a future application that will include the project description (RV campground will not be approved) and a detailed project cost breakdown,
- Village of Waskatenau Council advised they wish to continue and move forward with the project with the overall plan.
- Purchasable experiences will need to be explored and added in the project plan.
- Village can resubmit Expression of Interest in the next round of funding and now the lands will be fully secured.
- A workshop to review the new website and finalize the brand strategy will be on November 27, 2024 with Council and Administration. The municipal information for the website still needs to be populated and a meeting with Administration will be arranged to review the content.

The Village of Waskatenau Council attended the Smoky Lake County Council meeting on November 14, 2024 as a Delegation to request they rescind their October 10, 2024 motion to deny consent to the Village of Waskatenau to purchase the C.N. Lands.

The Village of Waskatenau received an email from the Smoky Lake County on November 14, 2024 advising they passed a motion at their November 14, 2024 Council meeting stating that Smoky Lake County Council rescinds the October 10, 2024 motion to deny consent and passed a new Motion stating that Smoky Lake County provide consent to the Village of Waskatenau to acquire the lands located within

Smoky Lake County, legally described as: "Railway Plan 371 BV Station Grounds in Township 59, Range 19, West of the 4th Meridian, comprising parts of Section NE 9 (4.44 hectares) and NW 9 (2.55 hectares), excepting thereout all mines and minerals"; pursuant to the requirements outlined in Section 72 of the Municipal Government Act, R.S.A. 2000, C M-26, as amended.

The letters for notification of the Village of Waskatenau intent to annex lands in the Smoky Lake County were sent out to affected (within annexation area) and adjacent (in the County, but abutting the annexation area) landowners on October 25, 2024. Municipal Planning Services was allowing owners 3-4 weeks to provide a response or feedback back by email, letters or telephone calls, and if any will share with the Smoky Lake County. The next steps will be to set up a meeting with the Smoky Lake County. The Village of Waskatenau asked Municipal Planning Services to facilitate the meeting between the Village and County on our behalf.
